VI. GAME AND MILEAGE FEES (PB/JR)

- Directors discussed the increase of game fees to be in line with other states.
- Charlie mentioned they have presented to the SCHSL member schools about moving to a flat fee structure. The response surprisingly from some schools was they did not feel a flat fee would be agreed upon by officials.
- Charlie suggested a detailed study be conducted including a comparison to fees for other sports. The results of the detailed study should be put into a proposal and submitted to the SCHSL office for review and discussion.

Action Item: SCBOA Committee consisting of Jake Rosiek, Paul Behr and Kyle B will work to draft the proposal for review by the SCBOA Directors prior to sending to the SCHSL office.

VII. HUDL (JR)

• Jake discussed with the Directors about the licensing of HUDL to provide access to all games for officials to be able to use as training.

VIII. OTHER BUSINESS

- Richie discussed with the Directors the draft proposal the SC Coaches Association and AD's will be preparing regarding the experimental use of a 35 second shot clock in select SCHSL sanctioned tournaments/showcases for the next 2 years. This proposal excludes the use of the 35 second shot clock during regular season (conference and non-conference, state playoffs and state finals.
- More details to be shared based on the decision from the SCHSL office on the experimental use of the 35 second shot clock.
- Coaches and AD's understands officials working the select tournaments/showcases will need to be trained on the use of the shot clock.
