I. CALL TO ORDER

Meeting was called to order at 6:00 pm by David Fauth (SCBOA President)

II. INVOCATION

III. SCBOA MINUTES (JULY 2021 MEETING)

The SCBOA Minutes from the July 13,2021 meeting were reviewed. Motion made by Rico Williams to accept the minutes as information without any corrections. Second by Steve Wood.

IV. 2021 STATE CHAMPIONSHIP GIFTS UPDATE – Paul Holland/Darrell Warren

Paul H. presented 2 options. The cost would be 30.00 with officials State Championship information included along with the SCBOA logo.

a. YETI Tumbler

b. Plastic cup

Directors discussed and selected option A (YETI tumbler) as the gift for the 2021 State Championship officials. Paul will place the order for 30. We will distribute as part of the 11/6/21 SCBOA meeting.

**V. SCHSL ONLINE 2021 BASKETBALL CLINIC – CHARLIE WENTSKY
(COMMISSIONER OF OFFICIALS)**

Charlie will provide a link to the SCHSL Online Basketball Clinic video with voiceover to each SCBOA Director for them to coordinate the review with their respective Districts. Each official attending the review will receive 1 point credit.

SCBOA Officials will be required to complete the review by the start of scrimmages 11/8/21

VI. SCBOA ANNUAL MEETING \SCHSL EXAM – ALL SCBOA DIRECTORS

The SCBOA Directors discussed the following options:

Option A - Meet in person at Spring Valley High School with smaller classroom assignments

Option B – Each District administer the SCHSL Exam. Director and 1 other person will proctor the exam for another District in the area.

Option C – Use the 2019 Exam score to be used as part of the calculation of the 2021-22 ratings.

The SCBOA Directors discussed each of the options. As part of the discussion, Charlie Wentzky shared with the Directors Spring Valley High school would not be available due to a scheduling conflict. An alternate site would need to be secured if it was decided to meet in person.

Directors of District 2 and District 5 shared their concerns from their respective District regarding meeting in person with a large group of officials based on the increase of COVID cases and deaths continuing to rise.

District 10 stressed their concern of rolling test scores over and not having a test. There are several reasons for this:

1. Prevents officials the opportunity to improve their test score. This prevents them from improving their rating and give them a better change of officiating a State Championship.
2. As much as I hate to say it, some officials will not study as much once they know we are not taking an exam. This being the second year in a roll of not taking the exam, some will not be as familiar with the rules as they would be if an exam is given. We all refresh our memories and/or learn something new each year that we prepare for the exam.
3. I believe the exam better prepares us as officials and makes us a better organization.

After lengthy discussion and voting **Option C** was selected as the forward plan for the 2021-22 season. The Director voting was as follows:

In Favor – Districts 2, 4, 5, 6, 7, 9, 12

Against – Districts 1, 3, 10, 11

Note: District 8 Director was not in the meeting and did not cast a vote.

All SCBOA officials who would like to have an opportunity to speak on their behalf as part of the ZOOM meeting should submit their request to their respective Director so they can be added to the agenda.

IX. SCBOA FACIAL HAIR POLICY – ALL SCBOA DIRECTORS
