- 1. A2 has hair extensions with beads. They are not securely fastened to the head. Ruling: A2 can secure the beads to their head or not play in the contest. There is no option that requires A2 to cut the beads from their hair.
- 2. A1 fumbles the ball, recovers it and then dribbles. A1 ends the dribble and then fumbles the ball again. A1 recovers the ball with both hands and with both feet in contact with the floor. A1 then uses his left foot as a pivot foot. **Ruling:** Legal
- 3. A1 is holding the ball with her back to the basket, As A1 steps into the lane with her right foot and turns to go up to shoot, B-5 places both hands on A-1's hip. The Lead official rules a handchecking foul. A-1 continues her movement and places her left foot on the floor before going up to release the try. The Center official sounds his whistle and rules a traveling violation. The ball goes through the goal. **Ruling:** Basket is not counted. A1 will shoot two free throws.
- 4. In an attempt to gain control of a loose ball in the air, A1 intentionally bats the ball to the floor, then catches the ball with both hands. A1 then dribbles the ball forward. **Ruling:** Legal
- 5. Four minutes before the scheduled start time of a contest, a technical foul should be assessed for each individual change and/or addition to the lineup in the official scorebook?
- 6. Shorts may be rolled at the natural waistband seam provided that no more than one manufacturer's logo is visible, and the rolling of the shorts does not pose a safety concern?
- 7. During a throw in, the ball is live when it is at the thrower's disposal?
- 8. A1 has a cut and is bleeding. Official directs A1 to the bench area to be replaced. Team A takes a timeout. Following the timeout, A1 enters the court ready to play. **Ruling:** A1 may not enter until the next legal opportunity to substitute.
- 9. A double foul occurs when two opponents foul each other at approximately the same time?
- 10. A closely guarded count has begun on A1, guarded by B1. B2 comes to double-team A1, and after three seconds, B1 drops off to stop a possible pass. **Ruling:** The count should stop, then begin again.
- 11. In an effort to avoid being detained by a double screen, B1 goes out of bounds. As he goes out of bounds, A4 has released a try and the ball is in flight. The try is good. **Ruling:** the goal counts and Team A will receive the ball for a designated spot throw-in at the spot where B1 went out of bounds.

- 12. A1 is dribbling in the frontcourt. The ball is deflected by B1 off A1's leg. While the ball remains inbounds, the ball retains frontcourt status unless it touches the floor/official in backcourt, or a player in backcourt?
- 13. A Flagrant Technical Foul cannot occur during a live ball?
- 14. Stationary B1 is guarding A1. A2 sets a stationary screen within B1's visual field just short of contact. B1, in attempting to continue to guard A1, contacts A2 before completing his first normal step. **Ruling:** This is an illegal screen by A2.
- 15. While a successful try from A1 is in flight, A2 excessively swings her arms and does not contact an opponent. **Ruling:** Whistle immediately for a violation, ball is dead, and the try does not count.
- 16. B1 has a legal guarding position about 1 foot from a sideline, when A1 tries to dribble between B1 and that sideline. A1 contacts B1 who is maintaining his legal guarding position. As a result of the contact, A1 steps on the sideline. **Ruling:** A blocking foul is charged to B1.
- 17. If a basket interference violation is ruled for touching the ball in the basket after entering from below, no points are awarded regardless of which team committed the violation?
- 18. B1 Fouls A1 on the perimeter. Team A is in the bonus. A1 then taunts B1. This is considered a double foul?
- 19. A1 is dribbling the ball in the backcourt. The official has a count of 8 seconds. A1 ends the dribble at the division line with the right foot on the floor in the backcourt. A1 steps into the frontcount with the left foot. As A1's left foot steps into the front court, A1 picks up the right foot and keeps it in the air so as not to travel. **Ruling:** The covering official stops the 10 second count once the right foot was lifted off the floor.
- 20. Two minutes into the first extra period (overtime), the official scorer informs the referee that the home team had an additional point in the 4th period that was not counted. The official scorebook is reviewed, and the Referee determines this to be accurate. **Ruling:** The game is ended immediately with the home team as the winner due to the corrected mistake.
- 21. A1 is shooting a free throw after a made basket. No teammates of A1 choose to line up in the marked lane spaces. B1, B2 and B3 all line up on the marked spaces on the same side of the lane. B4 occupies the lane space closest to the end line on the other side of the lane. **Ruling:** Legal
- 22. It is not possible for a player to travel during a dribble?
- 23. An airborne shooter is in the act of shooting until both feet return to the floor?
- 24. B1 has obtained a legal guarding position on dribbler A1. B1 is moving sideways and backwards to stay in front of A1 when A1 contacts B1 in the torso. **Ruling:** This is a blocking foul on B1
- 25. A1 shoots and in an attempt to block the shot B1 hits the net while the ball is in the air. The net gets hung up on the rim. A1's shot misses and A2 tips the miss into the basket and the ball becomes stuck in the basket. **Ruling:** A2's tap is successful.

- 26. A1 is fouled after returning to the floor after jumping and releasing a try. The basket is good. Team A is not in the bonus. **Ruling:** A1 will be awarded one free throw.
- 27. Once the ball is at the disposal of the free thrower, players occupying the marked lane spaces may not enter the free-throw semicircle until the ball touches the ring or until the free throw ends?
- 28. While facing the ball handler, A1 sets a blind screen on B1 with her feet shoulder width apart and one foot on the boundary line. A1 provides B1 with sufficient time and distance. B1 contacts A1. **Ruling:** Blocking foul on A1.
- 29. The penalty for an excessive time-out is a technical foul charged to the Head Coach?
- 30. A dribbler must avoid contact with a defender who has obtained a legal guarding position in their path by changing direction or ending the dribble?
- 31. One official calls a block on the defender and another official calls a foul on the airborne shooter. The ball enters the basket. **Ruling:** The officials charge a double personal foul, disallow the goal, and use the alternating possession procedure to resume play
- 32. The only methods for getting a dead ball live are: a throw-in, free throw, and a jump ball?
- 33. A1 controls a loose ball with his legs while B1 is tying up the ball with his hands. **Ruling:** Kicking violation on A1.
- 34. During a jump ball, A2 catches the ball with both feet on the floor, one foot on either side of the division line. With both feet on the floor, A2 starts a dribble, picks up the foot in the frontcourt and places it down in the backcourt. **Ruling:** Backcourt Violation
- 35. As A1's try is in flight, Team A's coach screams at the official for a foul that was missed and the official issues a Technical Foul for unsporting conduct on the coach. **Ruling:** Goal counts and Team B will be awarded two free throws and the ball at the division line opposite the scorer's table.
- 36. A1 drives to the basket for a layup. A1 ends the dribble and as A1 is taking the last step before jumping to release the layup, A1 is fouled on the arm by B1. A1 continues the motion, jumps, releases the ball and the ball goes through the basket. **Ruling:** The goal counts and A1 is awarded one free throw.
- 37. B1 catches a pass while airborne. He lands on his left foot, then his right foot hits the floor. B1 pivots uses his right foot as the pivot foot to gain space from the defender. B1 then starts a dribble. **Ruling:** Legal
- 38. A-1 is fouled in the act of shooting but time expires before A-1 releases the ball. The ball enters the basket. **Ruling:** The official disallows the goal and awards A-1 two free throws.
- 39. Only the head coach can determine the shooter for a technical foul?
- 40. A defender in legal guarding position may legally jump high into the air in their own vertical plane?
- 41. Penalties for fouls are administered in the order in which they occur?

- 42. A1 is fouled in the act of shooting an unsuccessful two point try. Inadvertently, the official announces one free throw for the first attempt. The free throw is unsuccessful and is rebounded by B5. Team B advances the ball to the frontcourt where the ball is deflected out of bounds by A5. At this point the scorer notifies the officials of the error of not awarding the second free throw. **Ruling:** The officials award A1 the second free throw with no players lined up along the lane. Play is resumed from the point of interruption with a throw-in by Team B at the spot closest to where the ball went out of bounds.
- 43. While A1 is dribbling the ball in frontcourt, A5 has only one foot touching the lane boundary line for 3 seconds. **Ruling:** This is a three second violation.
- 44. The penalty for any intentional foul is two free throws plus a designated spot throw-in at the division line opposite the scorer's table?
- 45. Team A has 6 players to start the contest. During the 2nd quarter A4 fouls out. In the 3rd quarter A2 breaks his foot. **Ruling:** Team A can no longer continue with the contest and will forfeit the contest to B.
- 46. The ball becomes live during a jump ball once it is legally touched by a player?
- 47. An official gets stuck in traffic and is late arriving to the contest for pregame. When he walks through the gym to the dressing room to meet the rest of the crew, he sees A1 dunk during Team A's warm-ups. **Ruling:** No technical foul on A1.
- 48. A5 received a pass in the low post with his back to the basket. B5 places an extended arm bar on A5's back. The arm bar does not affect A5's ability to move and play. **Ruling:** This is legal play.
- 49. A4 goes airborne and releases a shot with 1 second left. After releasing the shot while still in the air, A4 makes contact with B3 who has a legal guarding position. The ball goes through the basket. **Ruling:** A4 is called for a player control foul and the goal is cancelled.
- 50. A-1 catches a pass while in the air, lands on his/her right foot, jumps off that foot and lands on both feet simultaneously. A-1 lifts one foot and then starts a dribble. **Ruling:** This is a legal play.
