##### **RATINGS**

- Directors will receive their district rating spreadsheet by July 25, 2024.

- Tentative BT Exam Nov. 2. (Jill will enter exam scores and verify with each Director their spreadsheet is correct).
- Ratings will be sent to Arbiter November 4, 2024.
- Jill will enter make-up exam scores on the spreadsheet, verify the rating with each director, and manually update the rating in Arbiter.



## **BOOKING**

- BT schedules due in Arbiter October 1, 2024.
- Let Jill know as soon as possible any issues with schools or schedules. (Schools need to be made aware if Directors use Sub-group accounts and the number, or the SCHSL 101800 account)
- BT will be published 2 weeks out.
- BT Week 1 will be published November 15, 2024.

## **REGISTRATION**

- Registration- Opens August 1, 2024, Closes November 30, 2024
- Late fee \$30.00 starts October 16, 2024. ( This is added automatically beginning October 16, however, the late fee can be refunded to new officials. Send Jill an email stating this and a copy of the payment receipt they were emailed)
- Arbiter has additional security features. If an official receives a message during registration (Fraud, Verify SS#, etc.) they will need to contact Arbiter directly.

## **OFFICIALS**

- Each Director will receive a shared spreadsheet with their list of officials and the officials' email. This will be a centralized communication between Jill and each Director (and Sarah) for all officials, including new officials, registration completion, and eligibility. This is intended to simplify official updates and reduce emails.
- Jill will use the shared spreadsheets to update the rating spreadsheet for each district.
- New officials must be scoped and ranked before they appear on the Directors filter.
- Please remember Jill has limited ability in Arbiter. For situations she does not have the capability to see/correct, officials will need to call Arbiter. However, if Arbiter does not resolve the situation, let Jill know.
